Crime

During pupillage Danielle observed and assisted in a variety of criminal cases involving violence, sexual offences, and manslaughter.

Danielle regularly prosecutes and defends in the Magistrates courts dealing with cases involving offences against the person, weapons, dishonesty and public order. She also appeared successfully in the defence of the owner of a dangerous dog that caused injury.

During pupillage Danielle acted successfully for the defence of a vulnerable adult in a theft case involving issues of capacity, expert psychology evidence and a ground rules hearing. She appears in the Crown Court for mentions, appeals and committals for sentence; and is instructed by the Probation service in breach matters.

Danielle regularly appears in confiscation and forfeiture proceedings.

regularly acts for both sides in road traffic offences including dangerous driving matters and is regularly instructed in cases involving exceptional hardship and special reasons arguments.

She has also been instructed as led junior in a prosecution brought by the CQC.

Civil

Danielle acts on behalf of claimant and defendant in small claims trials; in road traffic issues and employer's liability. She regularly conducts Stage 3 hearings and has also acted in breach of contract matters and preliminary applications to strike out.
